Affidavit of Sharon Giles

- I, Sharon Giles, do hereby declare, under penalty of perjury:
 - I am an employed senior citizen residing in Illinois, and I am not a convicted criminal.
 - 2) Dr. Joseph L. Giacchino Jr. MD will be referred to as 'Dr. Giacchino'.
 - 3) Sometime in the year 2004, the medical clinic that is purportedly owned and operated by Dr. Giacchino, and is called the Melrose Park Clinic, charged my credit card in access of \$1,000.00. I disputed the claim with my credit card company as a fraudulent charge and it was reversed.
 - 4) Sometime in the year 2005, my physician Dr. Giacchino frightened me into cooperating with a purported plan to save Joseph Fosco from losing his life to a "Chicago Outfit Hit," requiring me to liquidate family holdings in order to meet the purported demands of the Chicago Outfit, and fund a seemingly legitimate medical practice operating as a skin care center. Dr. Giacchino explained to me that Joseph Fosco would soon be employed by the skin care center as a bonus for my cooperation; I have fully complied with the demands for money, iterated by Dr. Giacchino.
 - 5) Sometime in the year 2005, my physician Dr. Giacchino told me that Alex Gonzales (uncertain of correct spelling of last name), is involved in the purported plan to save Joseph Fosco's life.
 - 6) Sometime in the year 2006, Dr. Giacchino told me that as a condition of the settlement that he reached with the Chicago Outfit to save Joseph Fosco's life, I was required to purchase his 2003 Mercedes Benz automobile, so he would have less of a distraction from his financial efforts to save Joseph Fosco from being murdered.
 - 7) Sometime in the summer of 2008, Joseph Fosco advised me to investigate my prescription coverage records and Walgreens Pharmacy transactions, because Dr. Giacchino had purportedly prescribed medication in my name for the intended use of someone other than me, allowing my prescription coverage to cover the pharmaceutical costs involved.
 - 8) Sometime in the summer of 2008, I determined that numerous fraudulent prescriptions for diagnosis's unrelated to my medical history appeared in my name (see exhibits); prescribed by my physician Dr. Giacchino, via Walgreens in Northlake Illinois, which had been illegally paid for by my insurance company, Blue Cross Blue Shield of Illinois, without my consent or knowledge.
 - 9) On September 16, 2008, I made a report to the Northlake Illinois Police Department (police report # 08-19099) and to Blue Cross Blue Shield of Illinois (report # BCS-08-09-0101), reporting suspected prescription fraud in my name, purportedly by Dr. Giacchino (see exhibits).
